INTRODUCTION

Federal funding programs aim to improve transportation services for persons with disabilities, older adults, and individuals with lower incomes by ensuring that communities coordinate transportation resources provided through these programs. Coordination of transportation resources enhances transportation access, minimizes duplication of services, and facilitates the most appropriate, cost-effective transportation possible with available resources.

Door County first adopted a locally developed Coordinated Public Transit/Human Services Transportation Plan in 2008, subsequently updated in 2012, 2016, and 2020. In 2024, this plan was updated for the 2025-2028 planning period. This Plan identifies projects which may receive funds from Sections 5310, 5311, 5316, and 5339. (See Appendix A – Federal and State Transportation Program Descriptions.) Door County has utilized these programs in the past to provide for and coordinate transportation services throughout the County. (See Appendix B – Door County Transportation Providers and Services.)

Staff members from the Door County Land Use Services and Transportation Departments (Coordinated Plan Committee) updated this Plan with input from Dor-Tran Inc. D.B.A Door-Tran and Sunshine Resources, Inc.(formerly known as Sunshine House). Section I outlines the Wisconsin Department of Transportation’s (WisDOT) requirements for a coordinated public transportation plan and where those requirements can be found in this Plan. Section I also has the required target population assessments. Section II of this Plan provides an overview of public input received. Section II also provides strategies, action items, and a Program of Projects for the 2025-2028 transportation planning period. Appendices C – F provide more detailed information on the public input meetings, including the notification process and meeting notes.

Per State regulations, since Door County is an Environmental Protection Agency nonattainment area, this Plan will continue to be updated every four years or amended as needed.

SECTION I: DOOR COUNTY COORDINATED PUBLIC TRANSPORTATION PLAN REQUIREMENTS

Wisconsin Department of Transportation (WisDOT) Plan Requirements

Per WisDOT, Sections 5310 and 5311 projects are competitively selected for funding and shall be derived from a coordinated plan that minimally includes the following elements at a level consistent with the available resources and complexity of the local institutional environment:

- 1) An assessment (*inventory*) of available services that identifies current transportation providers (*public, private, and non-profit*);
- 2) An assessment of transportation needs for individuals with disabilities, older adults, and people with low incomes. This assessment can be based on the experiences and perceptions of the planning partners or on more sophisticated data collection efforts and gaps in service;
- 3) Strategies, activities, and/or projects to address the identified gaps between current services and needs, as well as opportunities to improve efficiencies in service delivery; and
- 4) Priorities for implementation based on resources (from multiple program sources), time, and feasibility for implementing specific strategies and/or activities identified.

The coordinated plan must be developed through a process that includes representatives of public, private, and non-profit transportation and human service providers, and participation by members of the public who can provide insight into transportation needs. Coordinated plans will reflect the availability of resources and the existence of populations served under these programs. A rural community may develop its plan based on perceived needs emerging from the collaboration of the planning partners, whereas a large urbanized community may use existing data sources to conduct a more formal analysis to define service gaps and identify strategies for addressing those gaps.

In addition to the four elements described above, WisDOT requires the three public participation items below to also be included in a coordinated plan.

1. An outline of the coordination planning process and meeting(s) format, including a summary of the participants' evaluation of the process;
2. A copy of the meeting record and/or narrative overview of meeting(s) to develop the coordination plan; and
3. Copies of the meeting invitation list and participant list(s), including the county and the individual's affiliation or representation.

Door County's Fulfillment of WisDOT Plan Requirements

The transportation plan and public participation requirements required by WisDOT, described above, can be found in this Plan as follows:

Assessment of Target Populations

The United States Census Bureau estimates that in 2022 the median household income for Door County was \$68,257, the average household size was 2.14, and the percentage of persons living in poverty was 8.7%. Per the Wisconsin Department of Workforce Development, Door County’s largest employing sector in 2022 was “Accommodation and Food Services” at 20.0% of total employment, but which accounts for only 14.5% of overall payroll. Door County’s annual average wage in 2022 was \$42,884, just over 72% of the statewide average of \$59,203. Much of this income disparity is due to fewer year-round employment opportunities.

The Census estimates Door County's median age to have been 53.6 in 2022, compared to 39.9 for the State of Wisconsin. Door County is tied with Bayfield County as the sixth oldest county in the state. Per the DWD, over 38% percent of the county's population will be over the age of 65 in 2040.

The above statistics indicate Door County has high populations of low-income, disabled, and/or elderly individuals. It is known to Door County's public transportation partners that individuals meeting these demographics are high users of public transit and in need of affordable, available, and accessible transportation.

SECTION II: TRANSPORTATION COORDINATION ACTION PLAN

The strategies and action items outlined below are derived from the county's 2021 - 2024 coordinated transportation plan and updated with recommendations from two public input meetings, comments received directly, and input from the Coordinated Plan Committee.

Strategies and Action Items

Meeting participants were first asked to review the following strategies that were noted in the 2021-2024 Coordinated Plan process. Meeting attendees were asked to respond if they felt things were being "Done Well" or could be "Done Better" in the five areas of transportation coordination.

Strategy 1: Increase planning efforts to address funding issues and unmet needs.

This section addresses issues related to sustainable funding for current services and for future expansions to serve the unmet needs and unique characteristics of the county's client population. Current information/updates are in *italics*.

Done Well:

- Potentially approach the City of Sturgeon Bay to contribute funds to D2D since the majority of rides are provided in this area (eventually, potentially approach all municipalities benefitting from services). *The City of Sturgeon Bay provided almost 10% of the County's local match for 2023.*
- Monitor agency fares to ensure appropriate payments to applicable organizations are being followed. *Ongoing.*
- Explore and implement a volunteer driver service within the public transit system to increase the in-kind match and reduce the local match required of the County. *Implemented in 2020.*
- Transportation needs for the growing elderly population:
 - individuals losing their driver's license or reduced mobility. *Ongoing.*

Do Better:

- Serve transportation needs for foreign workers getting to and from the county and within/around the county.
- There is a need for a vehicle with wheelchair accessibility for trips outside of public transit areas such as travel to and from Brown and Kewaunee Counties.
- Reduce denied rides during peak service hours (8 a.m. to 5 p.m., Monday through Friday) by adding a flexible fixed route service. *Route service was implemented 2020 and discontinued in 2021 due to low ridership. This route ran every Wednesday and was a*

free service. Public input meeting attendees suggested trying more flexible route options such as servicing other areas and/or adding more hours.

Strategy 2: Improve branding, marketing, and education to increase ridership and reduce confusion about service providers.

Done Well:

- Branding for the County's Transportation Department, which is now an umbrella department for the ADRC bus/van (DCC) service and D2D. The Transportation Department and these services are the County's public transit system. *Rebranding was completed in 2020-2021 by the County.*
- Marketing to first-hand contacts such as employers, church administrators, health care providers, and nursing homes/community-based residential facilities via mailings and presentations. *This is ongoing. Attendees reported that over 50 presentations per year are being done by the various providers.*

Do Better:

- Increase understanding and awareness of services. *Ongoing.*
- Improve knowledge/understanding of Door-Tran, D2D, and DCC services. *Ongoing.*
- Encourage civic and other groups to include information in their newsletters. *Ongoing.*
- Advertise services through all provider websites and social media in addition to all media outlets and printed materials. *Ongoing.*
- Implement a travel training program and advertise throughout Door County. *Ongoing.*
- Work with Destination Door County on marketing ideas and assistance.

Strategy 3: Improve and/or expand public transit (D2D and DCC) services, as appropriate.

This section covers service quality, infrastructure, and service area.

Done Well:

- Improve dependability and timeliness of Door 2 Door Rides (30-minute window is required). *Complaints regarding late pickups have decreased significantly. Cannot change pickup window until next RFP process, which happens in 2024. Currently researching what WisDOT requires for a shared ride taxi's pickup window.*
- Provide notification if drivers are going to be late. *Riders are notified as much as possible. D2D also has an App for Android phones to track rides.*
- Work on meeting current demand within the City and Town of Sturgeon Bay. *Ridership numbers have increased and denied rides have decreased.*

Do Better:

- Evaluate service hours and consider different/better hours and more drivers on the weekends, not necessarily provided by D2D. *Ongoing.*
- Provide centralized dispatch for any transportation need. *Attendees discussed the need for an App that connects people to providers based on their trip needs.*
- Expand service to rural areas in Northern and Southern Door.

SUMMARY

This Plan has been updated for the 2025 - 2028 planning period in accordance with WisDOT's requirements and guidelines for a coordinated transportation plan. When stakeholders met in January 2024, they discussed and addressed the adequacy of existing transportation services, issues of concern, and gaps in services. These discussions are formalized within this Plan.

Also, the Program of Projects, Table 5, has been updated to include the purchase of new vehicles for Door County, Door-Tran, and Sunshine Resources. Pursuant to this Program of Projects, all organizations that receive funds will continue to work in partnership to coordinate services and share resources. Door County will continue to utilize Section 5310 (Enhanced Capital and Operating Assistance Program for Mobility Options of Seniors and Individuals with Disabilities) to provide vehicles for human services transportation and mobility management projects and services. Door County will also continue to utilize Section 5311 and Job Access Reverse Commute funds to support public transportation projects and vehicle loans.

APPENDICES

APPENDIX A: FEDERAL AND STATE TRANSPORTATION PROGRAM DESCRIPTIONS

Federal Transit Administration Section 5307 – Capital and Operating Assistance

This program (49 U.S.C. 5307) makes Federal resources available to urbanized areas and transit capital and operating assistance in urbanized areas or Governors for transportation related planning. An urbanized area is an incorporated area with a population of 50,000 or more, as designated by the U.S. Department of Commerce, Bureau of the Census.

Federal Transit Administration Section 5309 – Capital Investment Grant (CIG)

This is FTA’s primary grant program (49 U.S.C. 5309) for funding major transit capital investments, including heavy rail, commuter rail, light rail, streetcars, and bus rapid transit. It is a discretionary grant program unlike most others in government. Instead of an annual call for applications and selection of awardees by the Federal Transit Administration (FTA), the law requires that projects seeking CIG funding complete a series of steps over several years to be eligible for funding. For New Starts and Core Capacity projects, the law requires completion of two phases in advance of receipt of a construction grant agreement – Project Development and Engineering. For Small Starts projects, the law requires completion of one phase in advance of receipt of a construction grant agreement – Project Development. The law also requires projects to be rated by FTA at various points in the process according to statutory criteria evaluating project justification and local financial commitment.

Federal Transit Administration Section 5310 – Enhancing Mobility for Seniors and Individuals with Disabilities

This program (49 U.S.C. 5310) provides formula funding to States for the purpose of assisting private nonprofit groups and local public bodies in meeting the transportation needs of the elderly and persons with disabilities when the existing transportation service is unavailable, insufficient, or inappropriate to meeting these needs. Funds are apportioned based on each State’s share of population for these groups of people.

Funds are obligated to the rural and small urban areas of the state by WisDOT based on an annual grant application. Projects within the Appleton, Green Bay, Madison, or Milwaukee urbanized areas also apply for Section 5310 funds through annual applications through the appropriate MPO or RPC that oversees these areas.

WisDOT ensures that local applicants and project activities are eligible and in compliance with Federal requirements, that providers have an opportunity to participate, and that the program provides for maximum coordination of federally assisted transportation services. Once FTA approves the application, funds are available for state administration of its program and for allocation to subrecipients within the state.

Typical projects under the 5310 grant include:

- Human Service Vehicles
- Mobility management projects
- Operating projects

Federal Transit Administration Section 5311 – Nonurbanized Area Formula Funds

The Formula Grants for Other than Urbanized Areas (49 U.S.C. 5311) is a rural program that is formula based and provides funding to states for the purpose of supporting public transportation in rural areas, with populations of less than 50,000. The goal of the program is to provide the following services to communities with populations less than 50,000:

- Enhance the access of people in nonurbanized areas to health care, shopping, education, employment, public services, and recreation.
- Assist in the maintenance, development, improvement, and use of public transportation systems in nonurbanized areas.
- Encourage and facilitate the most efficient use of all transportation funds used to provide passenger transportation in nonurbanized areas through the coordination of programs and services.
- Assist in the development and support of intercity bus transportation.
- Provide for the participation of private transportation providers in nonurbanized transportation.
- Wisconsin Employment Transportation Assistance Program (WETAP) funding for items such as vehicle repair or purchase and employment van pools.

Federal Transit Administration Section 5316 - Job Access and Reverse Commute Program

This program's (49 U.S.C. 5316) activities are eligible for funding under FTA's Urbanized Area Formula Grants (Section 5307) and the Formula Grants for Rural Areas Section 5311) programs.

The Job Access and Reverse Commute (JARC) program was established to address the unique transportation challenges faced by low-income persons seeking to obtain and maintain employment. Many jobs are located in suburban areas, and low-income individuals have difficulty accessing these jobs from their inner city, urban, or rural neighborhoods. These jobs, many times, also require working late at night or on weekends when conventional transit services are either reduced or non-existent.

Federal Transit Administration Section 5339 – Buses and Bus Facilities Program

This program (49 U.S.C. 5339) provides Federal resources available to States and designated recipients through formula allocations and competitive grants. Funds are used to replace, rehabilitate or purchase buses and related equipment and to construct bus-related facilities including technological changes or innovations to modify low or no emission vehicles or facilities.

State of Wisconsin Section 85.20 – State Urban Mass Transit Operating Assistance Program

The State Urban Mass Transit Operating Assistance program (codified in Wisconsin State Statute 85.20) provides operating cost assistance to transit systems in order to alleviate local tax burdens. Eligible applicants include municipalities or counties with populations greater than 2,500, as well as transit or transportation commissions or authorities. Public transportation services eligible for this program includes bus, shared-ride taxicab, rail or other conveyance either publicly or privately owned. Capital projects are not eligible for this program.

State of Wisconsin Section 85.21 – County Elderly and Persons with Disabilities Transportation Assistance Program

The County Elderly and Disabled Transportation Assistance program provides counties with financial assistance to provide transportation services to seniors and individuals with disabilities.

The purpose of this program is to promote the general public health and welfare by providing financial assistance to counties providing transportation services for seniors and individuals with disabilities, and to thereby improve and promote the maintenance of human dignity and self-sufficiency by affording the benefits of transportation services to those people who would not otherwise have an available or accessible method of transportation.

Wisconsin counties (or agencies thereof) are the only eligible applicants for funds available under s. 85.21, Wis. Stats, which are allocated on annual basis as determined by current population estimates. Private for-profit or private non-profit organizations may provide service for counties through contractual agreements

DESCRIPTIONS OF DOOR COUNTY TRANSPORTATION PROVIDERS AND SERVICES THAT RECEIVE LOCAL, STATE, OR FEDERAL SUPPORT

County of Door

Door County Transportation Department: <https://www.co.door.wi.gov/170/Transportation>

In late 2019, the County created a Transportation Department, located at the Aging and Disability Resource Center (ADRC) in the City of Sturgeon Bay, and hired a Transportation Manager to closely monitor the public transit system. Prior to this, the public transportation system was operated through the Door County Human Services Department.

The Transportation Manager works closely with Abby Vans, current contractor for the shared ride taxi, Door 2 Door Rides (D2D) and operates Door County Connect (DCC). The Manager continues to research D2D and DCC ride data in order to coordinate these services, further maximize service, and reduce costs. Funding to support these services will be a priority going forward.

Door County Connect (DCC) provides service with a 15-passenger, 3 (three) wheelchair bus and a 3-passenger, 1 (one) wheelchair minivan, both operated by paid and volunteer drivers. This service is door-to-door, operating Monday through Friday, primarily in the City of Sturgeon Bay. Rural service is provided as requested and as able. Ride requests are made through the Door County Transportation Department, located at the ADRC, with a preferred 24-hour notice.

Anyone is eligible for this service since it is part of the public transportation system in Door County. However, primary ridership consists of seniors and individuals with disabilities. In 2020, fares were \$2.00 per stop in the City of Sturgeon Bay and \$5.00 per trip in the extended area, which is outside of the City limits and up to 10 miles from the ADRC. If a rider is attending the lunch provided by the ADRC, they are charged \$2.00 round trip rather than \$4.00 round trip.

Door 2 Door Rides (Shared Ride Taxi): <https://www.co.door.wi.gov/1046/Door-2-Door-Rides>

In 2009, the Door County Transportation Consortium collaborated with Door-Tran to develop a shared ride program within the county that would be wheelchair-accessible and affordable for all. The Consortium, now known as Transportation Resources Improvement Partners (TRIP), worked with the County to develop a public transportation system, Door 2 Door Rides (D2D), which offers a range of transportation options for residents and visitors alike.

Door County contracted with Abby Vans of Neillsville to provide the initial shared ride taxi transportation portion and continues to be the contracted provider for D2D. This system started with two brand new specialty vehicles in 2010 and has since expanded to eight taxis, six of which are wheelchair accessible. Drivers have experience and training to assist passengers with special needs, whether they are in a wheelchair or simply students needing a ride home from a school activity.

Throughout the years, the D2D system has adjusted and grown to meet consumer needs. At this time, the service covers all of Door County, except for Washington Island. The areas of the county are broken up into five separate zones. The hours in the South (green) and Sturgeon Bay Core (orange) zones are Monday through Friday, 6:00 a.m. until 10:00 p.m., Saturday 7:00 a.m. until 10:00 p.m., and Sunday 7:00 a.m. until 6:00 p.m. The North (pink), Far North (yellow) and Far South (blue) zones have coverage Monday through Friday, 8:00 a.m. until 6:00 p.m.

Flexible fixed route connectors had been provided by Sunshine House Inc. and the ADRC bus/van service, however, these services were discontinued at the end of 2019 due to low ridership. D2D

provides a North-South Connector that is a door-to-door service between zones and operates Monday through Friday. This service requires a 24-hours advance reservation.

All public transit service is subsidized with State, Federal and local funds, making the rides very reasonable in cost. In the areas served by the D2D taxis, there are discounted fares for the elderly, disabled, children, and students up to the age of 22. Riders can pre-pay through Abby Vans automated system, pay their fare to the driver in cash, or pay with pre-purchased tickets. Individuals can arrange a ride within 30 minutes, if a taxi is available by calling (920) 746-6948 (local) or (888) 337-9485 (toll free).

Dor-Tran, Inc., D.B.A. Door-Tran: <https://door-tran.org/>

Door-Tran is a creative community network dedicated to connecting people to transportation services that are affordable, available, and accessible.

Under the direction of the steering committee, led by the United Way, the Door County Transportation Consortium was formed in 2007, a committee that subsequently launched Door-Tran as a 501(c)(3) non-profit in 2009. In 2018, the Transportation Consortium changed its name to the Transportation Resource Improvement Partners (TRIP), with the same mission to continue implementing and expanding transportation services in Door County.

- **Voucher Program.** Door-Tran's Half-Price Voucher Program was implemented in 2009 to assist individuals with offsetting their out-of-pocket costs when using a privately owned transportation agency. Door-Tran uses federal funds designated for seniors and persons with a disability to serve county residents. Additionally, local funds are raised to offer the half-price voucher program to low-income (at or below 200% Federal Poverty Level) Door County residents. Multiple partnerships with agencies exist across the county to provide voucher options to residents with physician ordered therapy or treatments and after-hours transport.
- **Veteran Volunteer Transportation Program.** Launched in 2011, this program provides free transportation to veterans of any age to US Department of Veterans Affairs facilities (VA) or designated choice providers for scheduled medical appointments. Door-Tran and County of Door have an agreement where the county provides a wheelchair accessible vehicle and fuel while Door-Tran provides the training and scheduling of volunteer drivers and registration and scheduling rider trips.
- **County-Wide Volunteer Transportation Program.** This program is also operated via volunteer drivers; however, they transport using personal, non-wheelchair-accessible vehicles. Drivers are reimbursed mileage and riders are charged a sliding fare based on miles traveled and household income levels. Door-Tran currently receives Section 5310 funds for up to 50% reimbursement of its operating deficit. Funding has also been received from United Way of Door County, Door County Community Foundation, Greater Green Bay Community Foundation, Bader Philanthropies, and other private grants.
- **Vehicle Purchase and Repair Loan Program.** This program was launched by Door-Tran in mid-2014. This program assists with employment retention and self-sufficiency. These are no interest loans offered to eligible low-income residents so that they have dependable transportation to and from work. Funding for this program is received through the Wisconsin Employment Transportation Assistance Program (WETAP) and distributed by WisDOT through their Section 5311 grant.

- **Half-Price Gas Voucher Program.** This program was launched in late 2015 to also meet the needs of employed and/or employment-seeking individuals. Locally raised funds support Door County residents with up to \$100 in fuel purchases at half-cost to the resident.
- **Vehicle Repair Grant Program.** This locally-funded program was launched in 2017 and offers up to \$500 in grant funds for those who cannot meet the employment requirements of the vehicle repair loan program. This program has been extremely beneficial to the disabled and those living on Social Security.
- **Mobility Management.** Navigating travel can be challenging or maybe even unknown for many in Door County. Door-Tran is an expert on transportation options in the County and helps people navigate those options. They offer support to people on how they can access the services, what the costs may be, and help plan their travel. Door-Tran works to match the unmet transportation needs of Door County residents with providers who may be able to meet those needs. These Mobility Managers lead on-going communication and collaboration efforts between individuals, businesses, and providers. Door-Tran continues to update and provide a transportation resource guide, which is available on their website and in hardcopy form.

Sister Bay Shuttle Bus

Beginning in 2019 and continuing to run currently, the Village of Sister Bay, with local funding, provides a no-cost Shuttle Bus service from June through October for residents, visitors, and local business employees. A new Sister Bay Village Shuttle Bus, funded by a Destination Door County Community Investment Fund Grant, CMAQ Grant, The Village of Sister Bay, and the SBAA, will be put into service in May of 2024.

A group interested in improving public transportation options in Northern Door County, The Peninsula Transit Coalition, started in 2018, continues plans to expand transportation services between communities by meeting with local municipal boards and Destination Door County and has a long-term goal to expand service as far south as the City of Sturgeon Bay. Door-Tran and Door County Transportation Department staff members are members of this Coalition.

Sunshine Resources, Inc. (formerly known as Sunshine House)

In 1971, a group of concerned Door County citizens founded Sunshine Resources of Door County (Sunshine House, Inc.) and offered services to eight people with special needs. Today, Sunshine Resources provides employment and social services for over 90 citizens with special needs and/or disabilities. Services offered include personal care, transportation, work services, supported employment, and activities.

Fixed-route transportation services are provided on a daily basis (door-to-door) with six wheelchair-accessible buses, one passenger van, and two wheelchair-accessible vans, one of which is a Bariatric Van. Sunshine Resources covers routes from North Algoma to Ellison Bay providing over 15,000 rides and driving 130,000 miles per year.

Sunflower Cottage, a division of Sunshine Resources, provides a Life Enrichment Program to seniors with Alzheimer's, Stroke, Parkinson's, etc. Sunflower Cottage will follow the same transportation services that are currently being utilized with Sunshine Resources. As the growth of services continue to grow and the wear on vehicles increase, SRDC is continually looking to invest in newer vehicles to ensure safe, operational and reliable transportation services.
